

JWCC CARES Reporting Emergency Financial Aid Grants to Student

1. JWCC completed and returned the Certification and Agreement with the USDOE on April 15, 2020. The institution has used 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to Students.
2. JWCC was awarded \$1,245,792 from the CARES Act. 50% of those funds (\$622,896) was distributed for Emergency Financial Aid Grants to students. The remaining funds are restricted to be used for the institution's expenses related to the disruption of instructional offerings during the pandemic.
3. \$599,750 was distributed to 1,309 students under Section 18004 (a)(1) of the CARES Act as of September 30, 2020.

6. For the spring 2020 term, to determine eligibility for direct emergency assistance grants, the college looked at students who had a change in delivery due to the pandemic. We also used the 2019-2020 FAFSA on file to determine if they met Title IV eligibility. Full time students were awarded \$500 and less than full-time were awarded \$250 based on the spring term.

For the summer 2020 term, all delivery of courses was provided online. Students enrolled in summer 2020, (no comma) were reviewed for FAFSA completion with awards being \$500 for six hours or more and \$250 for less than six hours.

During the spring 2020 term, the college established an Emergency Relief Request to assist those students enrolled that were having greater need due to implications of the pandemic. Students who applied through the Emergency Relief Request had Title IV eligibility confirmed through a current FAFSA being on file with the college. Full time students were awarded \$500 and less than full-time were awarded \$250 based on the spring term.

7. When funds were released directly to students, inserts were provided with checks explaining the reason for the distribution.
