*Emancipated Minor Students. The domicile of emancipated minor students shall be determined as if they were adults. A minor may become emancipated through marriage, formal court action, abandonment or positive action of alienation on the part of the minor. In all instances, alienation from care, custody and support shall be complete and the burden of satisfactory proof of emancipation shall be that of the minor student. Mere absence of the student from the domicile of the individual or individuals having legal custody of that minor student shall not constitute proof of emancipation. In no instance shall a minor student be eligible for emancipation when that student is taken as an income tax deduction by a second party other than a spouse. Attach court documentation of emancipation. Additional documentation may be request such as rental agreement, utility bills, or federal tax documentation.*

**Unaccompanied Youth who was Homeless**

**“Homeless”** means lacking fixed, regular and adequate housing, which includes living in shelters, motels or cars, or temporarily living with other people because you had nowhere else to go. **“Unaccompanied”** means you are not living in the physical custody of your parent or guardian. **“Youth”** means you are 21 years of age or younger or you are still enrolled in high school as of the day you signed your FAFSA.
